

[Press Release] Leitner Center Announces "Know Your Rights" Project for Hong Kong on International Day of Conscience

A new digital access to justice initiative to advance individual rights and civil liberties in the city

April 5, 2021

The Leitner Center for International Law and Justice is pleased to announce a new platform for access to justice in Hong Kong, **Know Your Rights HK ("KYR HK")**. A new project of the Center's work on rights and justice globally, KYR HK is launched at a critical time for supporting international rule of law principles in Hong Kong.

Hong Kong has long been praised by the international legal community for its rule of law, judicial independence, and wealth of international legal talent. The importance of the rule of law in Hong Kong underscores the value of a well-informed public that trusts the system. The KYR HK portal helps to enable this goal, allowing individuals to make the most of their rights (See: KYR HK--A One-Stop Shop for Legal Rights Knowledge, Appendix 1) at a time when crime statistics and related arrest numbers are at a record high in Hong Kong (See: Hong Kong's Legal Challenge in Numbers, Appendix 2). All eyes of the international legal, business, and civil society communities are on maintaining the independence of Hong Kong's legal system.

The Leitner Center announced plans for the new platform on April 5, the International Day of Conscience, which calls for the promotion of respect for human rights and

fundamental freedoms for all without distinction. Today, KYR HK joins Hong Kong's resilient civil society in promoting civil rights and liberties. The platform serves to equip the public with knowledge and tools to secure **due process** and improve **access to justice** (Appendix 3).

The platform includes toolkits and explainers through every step of the justice system. Information is presented in plain language in Chinese and English on the website, which will be launched this week. Further tools are made available through our social media channels. These tools are especially important in the context of rising crime statistics and a strain on the legal process.

Justice Is A Global Issue

In its ten-year "Vision 2030 for Rule of Law", the Hong Kong Department of Justice ("**DoJ**") prioritized the principles of UN Sustainable Development Goal 16, which calls for promotion of the rule of law internationally. For this vision to be true:

- Justice has to be real and accessible for all in Hong Kong, and
- Justice cannot thrive in a vacuum: a healthy and robust justice system has to be open and benchmarked against international standards.

KYR HK supports this vision of the rule of law in Hong Kong on both levels by empowering the individual, and by using international human rights and rule of law standards as changes in Hong Kong's legal landscape continue to develop.

The fundamental rights and freedoms of Hong Kong people are enshrined in the Hong Kong Bill of Rights Ordinance, which incorporates the International Covenant on Civil

and Political Rights (ICCPR), and the Hong Kong Basic Law also protects human rights and individual freedoms through its constitutional framework. KYR HK will provide tools for individuals to understand and navigate their due process rights and create a platform for assessing their ability to do so against the international and domestic legal frameworks that create them (*See:* Human Rights Protection Frameworks in HK, Appendix 4).

Launching KYR HK is a part of the Leitner Center's work on rule of law advocacy, capacity building, and education globally (*See:* About the International Day of Conscience, <u>Appendix 5</u>). "Hong Kong is not unique in the challenges it faces protecting human rights and civil liberties in the face of other government concerns," said Professor Martin Flaherty, Leitner Center Co-Director and Founder.

Protesters in Myanmar continue to be met with harsh reprisals against their calls for freedom, and protesters in the UK are demanding changes to a new police bill. In every context, the focus must be on the protection of internationally and domestically protected human rights to expression, assembly, and due process of law. "We know that the people of Hong Kong share these universal values with the rest of the world, and the international community will continue to monitor developments and support efforts to ensure these rights," Flaherty said.

Know Your Rights. Exercise Your Rights.

Hong Kong has long enjoyed a strong rule of law tradition and extensive civil liberties, anchored in international standards. The law benefits the individual and respects human dignity.

Built on shared values, KYR HK is here to demystify the notion that human rights are abstract or intangible. The Leitner Center firmly believes that institutions must be held accountable for the promises of human rights protection.

KYR HK - A One-Stop Shop for Legal Rights Knowledge

In light of recent developments in the legal and civil rights space in Hong Kong, the quality and amount of information in the public domain has proved a challenge even to legal professionals. The public and legal professionals will both benefit from user-friendly and up-to-date bilingual content about legal rights available to them in Hong Kong. The Leitner Center's new project will provide:

- Toolkits and explainers on the KYR HK website to help users through every step of navigating the justice system; and
- Complex and precise information presented in plain language on our social media channels for anyone at risk of arrest or for those who simply want to explore their civil rights in the Hong Kong context.

Appendix 2

Hong Kong's Legal Challenge in Numbers

A closer look at the latest publicly available crime data² in Hong Kong paints an alarming picture. Between 2010 and 2018, the overall crime rate (crimes per 100,000 people) saw consecutive annual declines, but has turned sharply upwards since 2019.

The total number of crimes recorded its 5-year high in 2020 at 63,232³, indicating a high number of arrests. Tens of thousands of civilians have been charged and faced with legal proceedings in the past two years - many of them for the first time in their lives, and many charges of serious nature.

Meanwhile, caseloads⁴ of the DoJ dropped by 7.4% in 2019 compared to 2018. The rise in the number of arrests in two consecutive years puts a tremendous strain on the justice system, resulting in delays in prosecutions and trials for those arrested.

Meanwhile, with only 12,000 solicitors, solicitor advocates, and barristers in Hong Kong combined, Hong Kong is fast approaching a situation where there simply will not be enough legal representatives for every defendant in the years to come.

It is therefore now more pressing than ever for the individuals to familiarize themselves with legal procedures and their legal rights in Hong Kong.

Appendix 3

Focus Areas: Due Process and Legal Aid Options

KYR HK provides a portal for self-help materials on legal procedure and knowledge of basic legal principles, with a view to being a resource with the following concerns and priorities in mind:

- Higher risk of arrests for individuals reflected in crime data. Together with reports of higher crime counts are individual and media accounts of alleged abuse of process during the course of stop-and-search, arrests and/or investigations, some potentially amounting to mistreatment or wrongful arrests⁵.
 - Fairness and transparency in the exercise of public powers are fundamental components of the rule of law. In this context, an empowered public is a well-informed one.
- Steps individuals can take to manage risks as they work their way through the justice system. The rule of law in Hong Kong is too important for people to give away rights at this junction. It is a reasonable demand that public bodies act in accordance with the law when dealing with individual citizens.
- Identification of all available resources and protections in the justice system. Hong Kong has an internationally competitive legal aid scheme. In

2020, the number of Legal Aid applications for criminal proceedings rose by 12% year-on-year; 77.7% of the applications were successful, as compared to 73.9% in 2019⁶. The general public needs more information on how to access this system.

Remaining uncertainties ahead - application of the National Security Law: a
new body of case law is emerging that may present legal challenges to existing
common law principles and codified human rights provisions under the Basic Law
and the Hong Kong Bill of Rights Ordinance. The Leitner Center will be watching
developments in this space.

Consistent with Hong Kong's aspiration to remain an "irreplaceable" international legal hub⁷, the international legal community has always and will continue to hold Hong Kong's justice system to high standards.

KYR HK will explore these topics on the portal and social media platforms with bilingual content. Our goal is simple: to reach as many people as possible, to build a community of allies in rights, and to make real Hong Kong's promise of civil rights and liberties.

About the International Day of Conscience

On this day, we revisit the 2019 General Assembly Resolution declaring April 5 to be the International Day of Conscience, affirming: "the need for the creation of conditions of stability and well-being and peaceful and friendly relations **based on respect for human rights and fundamental freedoms for all...**"

Art. 1 of the Universal Declaration of Human Rights states that **all human beings are born free and equal in dignity and rights** and are endowed with reason and conscience and should act towards one another in a spirit of brotherhood.

These values are universal and the international civil society must act in unity to deliver meaningful human rights work throughout the world.
